RETURN TO PLAY PROTOCOL

SEPTEMBER 4, 2020

Russell Memorial Multiplex

The Municipality of Russell Binscarth and The Russell Memorial Multiplex is committed to ensuring the health and safety of our user groups and staff. The facility will only be accessible to participants of pre-arranged bookings and appointments. Spectators will be limited.

This document is subject to change pursuant to the Current Provincial Guidelines.

GUIDELINES FOR ALL FACILITY USERS

- Stay home if you are experiencing symptoms, even if they are mild.
- Masks must be worn when entering, while being a spectator and when leaving the facility.
Exceptions: while eating or drinking.
- Self-screening for coaches, instructors, participants, and volunteers prior to entry of building. Individuals with COVID-19 symptoms will not be permitted on site for scheduled activities. <https://sharedhealthmb.ca/covid/screening-tool/>
- Allow physical distancing of two metres (6ft) at all times, except brief exchanges and when they are actively participating in a sport or activity.
- Avoid congregating in shared areas, such as the concourse & dressing room area of the facility.
- Use of hand sanitizer when you enter the facility.
- Follow guidelines from sport organizations and facility site plans to minimize physical contact and risk of COVID-19 transmission between participants.
- Users must bring their own bottled water; water fountains in the facility are closed.
- All facility users are expected to follow the most current Manitoba protocols.
- Hand sanitizer will be available throughout the facility. Dispensers will be located at entrance and exit points, as well as high-contact and high-traffic areas. When entering the facility all patrons are required to utilize the hand sanitizer.

FACILITY MAINTENANCE & SANITATION

New protocols and procedures are in place to maintain provincial standards to prevent the spread of COVID-19. This included, but is not limited to:

- Restricted facility access
- Ensuring signage and distance markers to educate patrons of physical distancing and hand hygiene
- Providing hand sanitizer throughout the facility
- Increased frequency of cleaning in washrooms and high traffic areas
- Sanitization of dressing rooms and all benches between groups; and
- Increased supervision

ARRIVAL & DROP OFF

When entering patrons should maintain 2 metres of physical distancing while enter the building. Individuals must sign in for tracing purposes and report directly to their designated area.

Entrance and exit to the building will be through the northwest doors with lower level exit from the building will be through the west player's door. **Entry at this door will not be permitted during this time.**

Access to the facility is limited as per your organizations recommendations before and after the scheduled ice time. Congregating is not permitted.

Players are recommended to come dressed or at least in their underlayer, minus helmets and skates.

CARE & CONTROL

The renter (coach/manager/parent/guardian) of the facility is responsible for the actions of their group members including:

- Team attendance,
- Execution of on-ice sessions,
- Player arrival/departure,
- Steps to practicing proper hygiene and,
- Protocols for participants that are feeling unwell.

GENERAL RULES

- For Practices entry onto the ice is at the Zamboni Man Door, while exiting the ice is the west door.
- Masks are recommended in the Timekeeper box.
- Dressing rooms are limited to individual teams only. Each team must provide their own wipes and hand sanitizer for use in the dressing rooms and on their bench.
- Showers are not available for use. Players are able to use dressing room washrooms and sinks only. User groups are responsible for sanitizing any shared equipment between uses.
- For private rentals, no more than 24 total participants will be allowed on the ice.
- Recommend not using benches and timekeeper box for non-game ice rentals.

SPECTATORS

Spectators will be limited to two per on-ice participant for practices. Spectators must report directly to a designated viewing area, with the exception of guardians who are assisting children with dressing. Spectators assisting children must report to designated viewing area immediately after children are dressed.

All spectators are encouraged to leave the facility immediately following the ice session. If required, one parent per player may stay in the facility to assist their child while all others leave the premise.

It is the responsibility of the user groups to have read and understood these guidelines and follows the Manitoba Health Restoring Safe Services guidelines/Public Orders.

The Russell Memorial Multiplex or The Municipality of Russell Binscarth is not responsible for any fines incurred by users or spectators for not following the Manitoba Health Restoring Safe Services guidelines/Public Orders as well as the Return to Play guidelines provided by the User Group's provincial sport body (if applicable).
